(a subsidiary of the top entity). As a result of the merger, which took place on 30th June 2015, the new top entity is ABANCA Holding Financiero, S.A. ABANCA Holding Financiero, S.A. is a financial holding company with the credit institution ABANCA Corporación Bancaria, S.A. being its subsidiary. Due to the merger, the competent authority of the supervised group (European Central Bank) has recognized this company as the new supervised entity and removed ABANCA Holding Hispania, S.A. from the list of the group entities subjected to prudential supervision on a consolidated basis in accordance with Regulation (EU) No 575/2013.
